Pro-rata subscriptions for new members in their first year

New members joining the WI in 2017 for the first time, i.e. who have not previously been a member of any WI in the past 10 years, will pay a pro-rata subscription depending on the quarter in which they join. The rate per quarter and the distribution are shown on the following table:

There is no pro-rata rate for dual members, which will be £19.00 at any time during the year. New WIs starting in 2017 will keep all of their subscription paid by their members in 2017.

***National Annual Meeting Pooling of Fares 2017: the delegate travel contribution for 2017 will be 0.40p per full member.**

National Annual Meeting Delegate Accommodation 2017: the delegate accommodation contribution will be 0.75p per member.

These charges should be paid from WI funds; this enables Delegates to attend the National Annual Meeting every year free of charge

New WIs formed in 2017 before the NFWI Annual Meeting will pay the pooling of fares contribution.

NFWI & Federation subs should all be paid in one sum to 'HCFWI'. We will send NFWI their portion of the subscription and the pooling of fares. HCFWI will retain the per capita charge in designated funds for delegate accommodation for future National Annual meetings.
