### Pro-rata subscriptions for new members only in their first year

New members joining the WI in 2019 for the first time, i.e. who have not previously been a member of any WI in the past 10 years, will pay a pro-rata subscription depending on the quarter in which they join. The rate per quarter and the distribution are shown on the following table:
